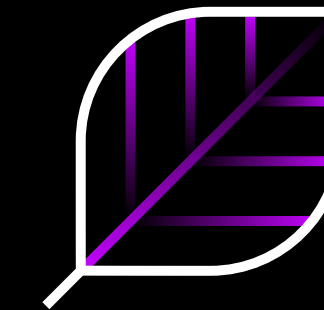


# Big ambitions for a smaller footprint

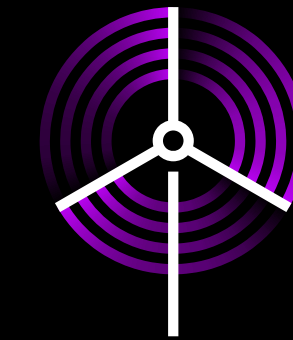
Early in calendar year 2022 (CY22), we set new aspirational commitments to reach net zero GHG emissions in our operations (scope 1) and purchased energy (scope 2) by CY50.

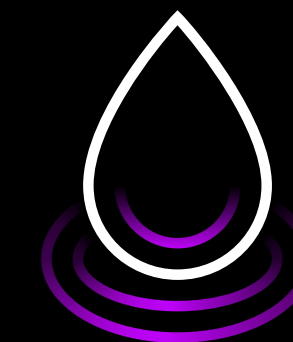
